ISSUANCE OF SABENA TECHNICS BOD AMO APPROVAL

We refer to your email dated 12 March 2024 on above subject.

We wish to inform you that the normal practice in accordance to our Civil Aviation Regulations is to conduct an audit prior to issuing or renewing an AMO approval.

Considering that the approval expired on 20 February 2024, it will not be appropriate to renew the AMO approval. Also, since an audit has not yet been carried out due to the short notice, we should not have normally issued an approval. However, considering that there is a maintenance work scheduled on Air Mauritius aircraft, we are exceptionally agreeing to re-issue an approval for another period of 12 months.

Please note that an onsite audit will soon be scheduled at your facilities and in case of any major finding noted, the approval may be suspended. Also, should any finding is raised related to the maintenance work performed, an assessment will be carried out and if required, the task shall be reperformed.

We are herewith enclosing the Revision 2, dated 20 March 2024 of the AMO certificate which is valid until 19 March 2025 unless the approval has been suspended or revoked.

We would also wish to draw your attention to Regulation 22 (5)(b) of the Civil Aviation Regulations, whereby you are required to seek approval at least 2 months prior to expiry of your AMO approval. You are henceforth, kindly requested to ensure compliance with the above.

The fee for the issuance of the AMO approval will be invoiced separately.
